Prime Contract Terms - DLA

The following clauses from the FAR, DFARS, and DLA are hereby incorporated by reference, with the same force and effect as if they were given in full text and are applicable, including any notes following the clause citation, to this Contract. Any reference to a "Disputes" clause shall mean the "Disputes" clause of this Contract. As used in the FAR clauses referenced below: (1) "commercial item" means a commercial item as defined in FAR 2.101; (2) "Contract" means this Contract; (3) "Contracting Officer" shall mean the U.S. Government Contracting Officer for SAS's government prime contract under which this Agreement is entered; (4) "Contractor" and "Offeror" means CONTRACTOR, acting as the immediate (first tier) subcontractor to SAS; (5) "Prime Contract" means the contract between SAS and the U.S. Government or between SAS and its higher-tier contractor working under a contract with the U.S. Government; and (6) "Subcontract" means any contract placed by CONTRACTOR or lower-tier subcontractors under this Contract.

Notes:

- 1. Substitute "SAS" for "Government" or "United States" throughout this clause.
- 2. Substitute "SAS Representative" for "Contracting Officer", "Administrative Contracting Officer", and "ACO" throughout this clause.
- 3. Insert "and SAS" after "Government" throughout this clause.
- 4. Insert "or SAS" after "Government" throughout this clause.
